

VI. Laws of Divine Establishment and the Royal Family Honor Code: Review

Continued review beginning at paragraph J. Some Additional Documentation, 02-05-95A CWL061 through point 22 where we took up a brief synopsis of the Five Cycles of Discipline. In the discussion of the indicators for Third Cycle activity, we went to the following analysis of the 19 April 1995 bombing of the Murrah Federal Building in Oklahoma City, Oklahoma.

Since the bombing of the Murrah Federal Building in downtown Oklahoma City last Wednesday, trends associated with the third cycle have certainly crossed some of your minds.

Let's take a moment to analyze this event and see if we can discern the cause-and effect process which resulted in this act of violence and revolution.

What we have seen is not an act of terrorism. This was a counterattack in what can only be classified as civil war.

First of all, let me make crystal clear that if these men who have been apprehended are indeed the ones who torched the building in Oklahoma City, causing the deaths of over a hundred people including many children, then they should be executed. They have performed an act of lethal violence against fellow citizens, apparently designed to fulfill revenge motivations against certain agencies of the Federal Government.

At no time in recorded history has violence ever resulted in solving political problems. There is no biblical justification for what has occurred in Oklahoma. This action runs completely counter to those principles we have been studying regarding the Christian's ambassadorship function which is, influence, not control.

With all of this in mind, let's see if we can note the cause-and-effect sequence which led to this tragedy. Commentators constantly harp to the experts over finding "*root causes*" for things of this nature. I will present my analysis—you can accept it or reject it.

Principles: Freedom without authority leads to anarchy. Authority without freedom leads to tyranny. We are going to see both principles come into focus in our analysis.

First of all, I do not know what goes on in the conscious mind of the people involved in the events I am about to relate to you. But I do know the functions of their sinful natures which are playing out a cause-and-effect scenario which has resulted in this latest crime of murderous incendiarism and has unleashed the destructive trends which are indicative of the third cycle. The hydra-headed monster of discontent, argumentation, sedition, insurrection, and revolt has been unleashed and will not be easily restrained.

There is no way any Christian can approve of what took place in Oklahoma City. Nevertheless, if we are to seek the "*root cause*" we must strive to objectively analyze all of the events which led to this effect. By doing so we can reveal a problem which if not corrected will lead to further expressions of violence by the emotionally driven crusaders of our society.

Emotionally charged men, driven by self-righteous indignation, are capable of justifying murder if they rationalize that they, or others, are the victims of unfair, unjust, and undeserved suffering.

Our national Zeitgeist has sold out to the distorted mythologies of psychotherapy and thus totally ignores the presence of the sinful nature in the decision-making processes of the human soul. As a result, our government makes decisions based on ideology and political expediency without recognizing that people without doctrine will at some point react violently whenever there is a misuse of authority.

King David clearly understood that no person who holds a position of divinely-approved authority can govern effectively unless he is just.

2 Samuel 23:3 - He that rules over men must be just, ruling in the fear of God.

David learned the hard way. In 2 Samuel 13 we see the account of Israel's Crown Prince Amnon's rape of his half-sister, Tamar. When David failed to punish Amnon for his crime, it infuriated his other son, Absalom, Tamar's full brother. Self-righteous indignation brewed in Absalom's soul and he fomented a revolution against his own father. Absalom, who at Amnon's death himself had become the Crown Prince, was killed in the Battle of the Forest of Ephraim.

The defrocking of his daughter Tamar, and the violent deaths of his two sons, Amnon and Absalom, were a part of David's divine discipline for his miscarriage of justice.

The greater sin was Absalom's and he paid with his life. But his sinful nature would not have been unleashed had David ruled justly.

It must also be stated that when there is anger and hatred in the souls of men, there will ultimately be found an excuse to vent those emotions.

This is why government must be very cautious to never violate the rights, the privacy, the property, or the freedom of those it is constituted to serve.

Such however, has unfortunately been the case for out-of-control agents of both the Federal Bureau of Investigation and the Bureau of Alcohol, Tobacco, and Firearms. On two occasions they have provided what the Romans called the *casus belli*—that which justifies war—once under the Bush Administration and once under the Clinton Administration.

The first occurred in 1991 or Ruby Ridge, Idaho. Here is a summary from:

Two years later, almost to the hour, self-righteous indignation justified in the souls of a few anti-government crusaders an act of unspeakable revenge which took place in Wednesday in Oklahoma City.

What is the thought-process of individuals such as these? Well, it is not one so very unusual for citizens of a contorted *Zeitgeist*. Peace, order, and justice are maintained in a society when a maximum number of its people utilize establishment and/or biblical problem-solving devices under pressure. When the nation has been effectively stripped of such defensive measures, then the souls of the people become vulnerable to the assaults of outside adversity.

Those who are in the hatred complex and function under emotional sins are easily led into overt action when injustice excites their self-righteous norms and standards.

Self-righteous indignation occurs and up from the sinful nature comes the motivation for corrective action. Crusader arrogance then begins to function and justifies itself because of the belief that it is right and the agent of the perceived injustice is wrong. This is quickly accompanied by the emotional sins of anger and hatred.

All these sins quickly rip holes into the stream of consciousness and begin to dictate policy and procedure to the individual.

Although the Ruby Ridge and Waco assaults were unjust actions taken by our government, the Christian is able to isolate these adversities on the outside of his soul. The biblical problem-solving devices prevent these pressures from entering the soul as stress.

However, once inside, anger and hatred lead to vindictiveness followed by loathing, animosity, and revenge motivation. If the person has any doctrine, it is blacked out at this point. He is controlled by his emotion and an insatiable lust for vindication.

The sinful nature always solves problems with violence when permitted to run its course and thus revenge motivation moves into revenge modus operandi which is expressed in the form of violent retribution.

The target was the Murrah Federal Building in the middle of the country, Oklahoma City, Oklahoma. Inside were the district offices of the FBI and the BATF among others. Their and others' children were inside as well, just like at Ruby Ridge and Waco. Innocent people died—needlessly—tragically—ghastly, and it occurred on all three occasions.

“He that rules over men must be just, ruling in the fear of God.” Whenever there is just government, the sinful natures of the people are restrained—no outside adversity to focus internal stress on souls filled with the garbage of self-righteous arrogance.

The bombers of Oklahoma City are guilty of a hundred murders, motivated by anger, hatred, revenge motivation, and vengeance. It was a direct attack on representatives of the United States Government. They must be brought to justice and executed.

However, Janet Reno, Louis Freeh, and the various out-of-control agents of these two federal bureaus must be brought to justice as well. They are guilty of the murder of a hundred people themselves, including children—all innocent.

Waco, then, is the *“root cause”* Tom Brokaw is so sincerely searching for. There are thousands of angry, hate-filled clones like the ones who acted Wednesday living in America. Their sinful natures lust for justified revenge. If justice is not served on both sides, they may well decide to strike again.

When the perpetrators of the Oklahoma City massacre are duly executed, their emotion-charged cohorts will have their renewed justification for more violence. Since I hold no confidence that officials of the Clinton Administration will be brought to justice, then the prospect of another Oklahoma City must surely be an ominous consideration.

That's why I call this event, not an act of terrorism, but the first battle of a civil war and the harbinger of the third cycle of discipline.

At this point a serious question needs to be asked. Would the Clinton Administration purposefully foment such actions as occurred Wednesday? If not, have they at least been ignorantly compartmentalized by Satan into a course of action which will result in a gross curtailment of this client nation's freedoms?
